## 3.i)MEMBERSHIP: -


- 1.General membership is unlimited. - 2.Un-employed graduates need not to pay annual fee, but they have to pay the admission fee.

## ii)CATEGERY OF MEMBERS:-

## I.PATRONS:-

- 1. Maximum number of PATRONS are 50 members.
- 2.To become the member of society.he/she should be completed minimum graduation(or) govt/central/PSU employee not less than One years service(or) any philanthropist will be specilly considered, who must be recommended by two members of society and must be approved by the EC ..
- 3.Each member of society should be donated fee lumpsam once minimum Rs;25000/- (or) special exemption to be given to any member by considering with his/her commitment towards doing the social service with not less than 3 years profile experience with the approval of EC...
- 4. All the society members of patrons will be act as advisory body to the society on time to time.





- 5. society members "number" can be enhanced on time to time with reference on demand with the approval of 1/4 majority of society members and simple majority of members.
- 6. society member fee can be enhanced on time to time with reference on demand with the approval of 1/4 majority of society members and simple majority of members.
- 7.Any society member can be disqualified. He/she absent without leave and does not attend three consecutive meetings of the society or for one calendar year whichever is earlier, with the approval of the EC and simple majority of members.
- 8. Honorary members shall not be required to pay any fee. society HONERARY members "number" can be enhanced on time to time with reference on demand with the approval of the EC and simple majority of members.
- 9. Society Honorary members and patrons will be permanent invitee to all society programmes.

#### **EXECUTIVE BODY:-**

The executive body will be selected from the members, priority will be given to the PATRONS. All the body will be elected by the 2/3 majority of society members of Patrons.

- 1. The founder and president will be appointed one among the society member by the EC.
- 2. He/She shall be holds society responsibilities for FIVE YEAR tenure. if he/she may be continued on special circumstances for the next one year with the approval of the EC
- 3. Founder PRESIDENT and Secretary will be permanent invitee for all society programmes in future.

## **II.LIFE MEMBERSHIP:-**

- 1. Life members: Lump sum fee of Rs.5000/- payable on admission.
- 2. To become the life member of society. He/she should be completed minimum graduation(or) govt./central/PSU employee not less than one years service(or) any philanthropist will be specially considered, who must be recommended by two members of society and must be approved by the EC and simple majority of members...
- 3. Life members -membership is unlimited
- 4. Life member fee can be enhanced on time to time with reference on demand with the approval of of EC and simple majority of members.
- 5. Any society life member can be disqualified. He/she absent without leave and does not attend six consecutive meetings of the society or for two calendar year whichever is earlier, with the approval of EC and simple majority of members.

## iii)ADMISSIONFEE AND THE ANNUAL SUBSCRIPTION OR MONTHLY SUBSCRIPTION:-

- 1. Registration fee: Rs.100/-
- 2. Annual Subscription: Minimum Rs. 1000/- as per member will and wish
- 3. Annual fee of Rs.1000/-, payable in the month of April every year or at the time of Registration.
- 4. No refund shall be made in case members resign / removal



## 4.GENERAL BODY:-

- i) Annual General Body will meet once in a year i,e., in the month of APRIL.
- ii) FUNCTIONS:-
  - 1)To pass the budget for the ensuring year and approve expenditure statement of previous year.
  - 2)To approve the reports of the activities of society.
  - 3)To elect the Executive Committee etc.
  - 4) To appoint the auditor.

## 5.EXCUTIVE COMMITTEE:-

- i)Executive committee shall consist of Maximum (21) Members and out of them, the following office bearers shall be elected by the E.C Viz., President, General secretary, Joint secretary, Treasurer and the remaining persons all the EC members.

# FUNCTIONS OF THE EXECUTIVE BODY AND OFFICE BEARERS:-

The President shall preside over all the meetings of the General body and the Executive Committee and shall have a casting vote. He shall supervise the activities of the SOCIETY.

#### 2 Vice President:

The Vice-President shall assist the President in discharging his functions. in the absence of the President, he shall perform the duties of the President.

#### 3. General Secretary:

The Secretary shall be the chief executive officer of the society and custodian of all records relating to the society and correspond on behalf of the society. He shall be responsible for recording all minutes of the meetings of General body and the Executive Committee and shall supervise the meetings.

The treasurer shall be responsible for all the financial transactions relating to the society and for maintenance of accounts and vouchers. He shall prepare the budget of the society under the guidance of the Executive Committee.

All library books and documents of the society shall be kept at the office of the society and should be kept in charge to one of the society for safe custody office secretary. The society/office secretary so appointed should maintain the register of the library books and other important documents of the society.

## **5.JOINT SECRETARY:**

Joint Secretary shall have vested in him organizational responsibilities such as enrollment of new members, organize them properly so that they may get opportunities to show their art and talents. He shall supervise the cultural and sports activities conducted or represented by foundation in various tournaments. He will organize all such functions which are helpful to promote banjara community in the society, social solidarity and national integrity. He will assist and follow the instructions of President/General Secretary from time to time in the above matter.





#### 6. OFFICE BEARERS:-

They shall carry-out such functions as may be entrusted to them by the Executive Committee.

03. Executive Committee shall be elected from the members of the Patrons for a period of 5 years, by the members of the Executive Committee, subject to the approval of General body of the society.

04. If a vacancy is caused for any reason and the same is not filled by the Patrons, Which it ought to have been filled, the vacancy may be filled by the Executive Committee and such member shall hold office till the conclusion of the next Annual General Meeting.

7. QUORUM: Half of the total members for general body meeting to decide the agenda of the society and 1/4 for Executive Committee meeting,

#### 8. FUND:

- a. The general fund of the society shall consist of subscription from members, donations etc., and shall be deposited in any nationalized scheduled bank or coop Bank approved by the State Government. The treasurer shall keep not more than Rs.10,000/- (Rupees ten thousand rupees only). With him for emergency and any miscellaneous expenses.
- b. Account in the name of society in a Bank / Coop Bank shall be opened or closed by a resolution/s of the EC. A copy of which shall be forwarded to the Bank Concerned.
- c. All Accounts in the Banks shall be in the name of society and shall be jointly operated by any two from the president, General Secretary and Treasure. Treasurer signature is must
- d. Accounts in Banks in the name of society shall be maintained in proper order required by rules and regulations and shall be audited every year by auditor, appointed by the Executive Body.
- e. To organize and conduct charity shows, dramas, lectures, exhibitions of the like for raising funds by way of donations, grants, gifts etc., to the finance activity of the society

## 9.AMENDMENTS:-

No amendment or alternations shall be made in the objects of the SOCIETY, unless it is voted by 2/3rd of its members present at a special meeting convened for the Purpose and confirmed by 2/3rd of the members present at a second special meeting.
